President Rollie Gibbs opened the meeting and then asked Patty Haack, Secretary/Treasurer, to conduct the remainder of the meeting.

Minutes of Prior Meeting

The minutes of January 13, 2019 meeting were unanimously approved by attending board members.

Financial Report

The LVHSAA Income and Expense Statements and Balance Sheets as of 02/17/19 were reviewed and unanimously approved by the board. There were no unpaid expenses.

2019 Budget

The budget for 2019 was reviewed, and with a couple of revisions, was unanimously approved by the board. There were no significant variances.

COMMITTEE UPDATES

Fund Raising

Allen and Ronnie met again recently with Jolene Mitchell at the Las Vegas Academy and have set the date of Thursday, October 17, 2019 for the "Have You Visited Your History Lately" fund raiser. Jolene is having the Academy prepare a flyer to be included with the Wildcat Reunion mailing in early July. The event will be a joint fund raiser for the LVHSAA and the Las Vegas Academy. Plans include selling bronze plaques that will be installed on the columns by the entrance to the Performing Arts Center. Patty provided costs of the bronze plaques that we purchased for the Senior Squares monument. Ronnie will check to see if there are local companies that we might be able to purchase plaques from. Since we cannot serve liquor on the school premises, we are considering holding a cocktail party at one of the attorney's offices located near the PAC. The event might also include speakers and entertainment by students of LVHS and/or the LVA. Allen, Ronnie, Crystal and Maria will be meeting with Jolene again in the near future and will present updated plans at our next meeting. We will include a "Save the Date" notification in the March Wildcat Tales.

At our prior meeting, Laura Ungaro proposed a possible fund-raising idea where merchants would give a discount to alumni. Due to illnesses, Laura was not able to get together with Jill and Laura C. They will give an update at our next meeting.

Membership

We gained two new members since our last meeting. No members passed away since January. Postcard reminders were sent out in January and we have now received 44 renewals since our last meeting. Our overall paid membership is up to 409 from 366, including 227 annual members and 182 lifetime members. With 8 honorary and 11 free members, we have a total of 428 members in good standing (up from 385). We still have a total of 83 memberships that expired at the end of September and have not yet been renewed. Patty prepared letters to the LVHS staff member alumni, inviting them to join the LVHSAA. Jill will be delivering them to the school.

Scholarships

The board decided that we will offer additional scholarships to previous recipients, to be used for a second semester or second year. Jill developed criteria for qualifications and a form to be completed by applicants, which the board unanimously approved. All scholarship applications are due to us by March 1. Jill will pick up the applications from the school during the week of March 4 and the committee will review them on March 13.

Wildcat Reunion 2019

The first 2019 committee meeting will be on March 31, immediately following the Board Meeting. Cristina Sa has informed us that she will not be the cheer coach next year. She will let us know as soon as she knows who her replacement will be.

PROGRAMS AND GOALS

Class Reunions

Classes of 1953, 1954, 1956, 1959, 1964, 1969, 1979, 1989 and 1999 have starting planning their 2019 reunions. We have not heard from 1949, 1974 1984, 1994 or 2004 and don't have contact names for some of those classes. Dave will put a message on our Facebook page asking for contacts from those classes.

Grants

We have not received any new requests for assistance.

Ronnie mentioned a grant program called Community Development Block Grants (CDBG). Laura Ungaro volunteered to look into this program and will provide details at our next meeting.

Homeless and Needy Students

No update. Jill will talk to the school counselors to be sure they keep our grant program in mind.

LVHS Newsletters

Laura U. wrote an article which will be published in the March issue of the Desert Breeze. The Desert Breeze Advisor, Julie Wilde, sent us copies of the December issue. A motion was made and unanimously approved by the board to make a donation of \$100 to help with future mailing costs of this publication.

Scholarship Mentoring

Jill will contact some of our previous scholarship recipients to see how they are doing or have done with their studies and to encourage them to stay in touch with us. Patty read an email received recently from one of our 2013 recipients and will include his update in the next Wildcat Tales newsletter.

Senior Squares

Nothing to report.

Vehicle Donation Program

No update.

Wildcat Float

Rollie advised that the float needs refurbishing. Patty will research possibilities and pricing on-line. This will be discussed at our next meeting.

They have offered to give us the one we are missing if we will give them the three duplicates that we have.
