Allen promised to get some fighter jet pilots from Nellis AFB to ride the float in the 2018 Veterans Day Parade.

### Wildcat Lair

Bruce presented his idea of the LVHSAA raising funds to build a Wildcat Lair building on the corner of Sahara and Treeline Drive, and the possibility of CCSD deeding the land to us and then leasing it back once from us once the building is completed. This would be a multi-purpose building, primarily a teaching facility, and would include a media center, recreational area for students, and an LVHS alumni center and museum. A motion was made and approved by a 4 to 2 vote for Bruce to contact Jeanne Hamrick (who helped raise funds for the new Gorman High School) and ask her to submit a proposal to us outlining the process and costs to undertake this major project.
